By letter dated May 13, 2002, which has been filed in the above-referenced docket file, prior counsel for Aloha Utilities, Inc. (Aloha or utility), provided Commission staff with information concerning the circumstances surrounding the mistake in billing the new service availability charge approved by Commission Order No. PSC-01-0326-FOF-SU. In that letter, counsel stated that the President of Aloha:

had his staff send out the attached first notices to all current developers and builders informing them of the increase in service availability charges applicable to all future connections. Soon thereafter, for all of the developers who would have arrearages in such service availability charges related to connections made between May 23, 2001 and the date of his letter, a second notice was forwarded to those affected developers outlining the amount of potential arrearages and suggesting that they contact the Utility immediately to discuss appropriate payment.

Along with that May 13 letter, counsel supplied staff with certain attachments; including a copy of a list of new connections made from May 23, 2001 through April 12, 2002, and copies of some of the above-described letters sent to "all current developers and builders." Please furnish staff with copies of all relevant letters which Aloha presumably sent to the following developers/builders who appear on the list of new connections but for whom no such letter(s) were copied to staff:
