### NOTICE OF HEARING ON APPROVAL OF FIRST AMENDED PLAN OF LIQUIDATION OF THE DEBTOR AND THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS

On June 14, 2002, the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") approved the First Amended Disclosure Statement Accompanying Plan of Liquidation of the Debtor and the Official Committee of Unsecured Creditors (the "Disclosure Statement") (Docket No. 711). STAR Telecommunications, Inc. (the "Debtor") and its Official Committee of Unsecured Creditors (the "Committee" and together with the Debtor, the "Plan Proponents") filed the Disclosure Statement in support of the First Amended Plan of Liquidation of the Debtor and the Official Committee of Unsecured Creditors (the "Plan") (Docket No. 712).
