INSTRUCTIONS FOR PROOF OF CLAIM FORM

The instructions and definitions below are general explanations of the law. In particular types of cases or circumstances such as bankruptcy cases that are not filed voluntarily by a debtor, there may be exceptions to these general rules.

DEFINITIONS

Debtor

The person, corporation, or other entity that has filed a bankruptcy case is called the debtor.

Creditor

A creditor is any person, corporation, or other entity to whom the debtor owed a debt on the date that the bankruptcy case was filed.

Proof of Claim

A form filed with the clerk of the bankruptcy court where the bankruptcy case was filed, to tell the bankruptcy court how much the debtor owed a creditor at the time the bankruptcy case was filed (the amount of the creditor's claim). This form must be filed with the clerk of the bankruptcy court where the bankruptcy case was filed

Secured Claim

A claim is a secured claim if the creditor has a lien on property of the debtor (collateral) that gives the creditor the right to be paid from that property before creditors who do not have liens on the property

Examples of liens are a mortgage on real estate and a security interest in a car, truck, boat, television set or other item of property. A lien may have been obtained through a court proceeding before the bankruptcy case began. In some states a court judgment is a lien. In addition, to the extent a creditor also owes money to the debtor (has a right of setoff), the creditor's claim may be a secured claim. (See also Unsecured Claim)

Unsecured Claim

If a claim is not a secured claim it is an unsecured claim. A claim may be partly secured and partly unsecured if the property on which a creditor has a lien is not worth enough to pay the creditor in full.

Unsecured Priority Claim

Certain types of unsecured claims are given priority, so they are to be paid in bankruptcy cases before most other unsecured claims (if there is sufficient money or property available to pay these claims). The most common types of priority claims are listed on the proof of claim form. Unsecured claims that are not specifically given priority status by the bankruptcy laws are classified as *Unsecured Nonpriority Claims*.

Items to be completed in Proof of Claim form (if not already filled in)

Court, Name of Debtor and Case Number:

Fill in the name of the federal judicial district where the bankruptcy case was filed (for example, Central District of California), the name of the debtor in the bankruptcy case, and the bankruptcy case number. If you received a notice of the case from the court, all of this information is near the top of the notice.

Information about Creditor:

Complete the section giving the name, address, and telephone number of the creditor to whom the debtor owes money or property, and the debtor's account number, if any one else has already filed a proof of claim relating to this debt, if you never received notices from the bankruptcy court about this case, if your address differs from that to which the court sent notice, or if this proof of claim replaces or changes a proof of claim that was already filed, check the appropriate box on the form.

1. Basis for Claim

Check the type of debt for which the proof of claim is being filed. If the type of debt is not listed, check "Other" and briefly describe the type of debt. If you were an employee of the debtor, fill in your social security number and the dates of work for which you were not paid.

2. Date Debt Incurred:

Fill in the date when the debt first was owed by the debtor.

3. Court Judgments:

If you have a court judgment for this debt, state the date the court entered the judgment.

4. Total Amount of Claim at Time Case Filed:

Fill in the total amount of the entire claim. If interest or other charges in addition to the principal amount of claim are included, check the appropriate place on the form and attach an itemization of the interest and charges.

5. Secured Claim:

Check the appropriate place if the claim is a secured claim. You must state the type and value of the property that is collateral for the claim, attach copies of the documentation of your lien, and state the amount past due on the claim as of the date the bankruptcy case was filed. A claim may be partly secured and partly unsecured. (See DEFINITIONS, above)

6. Unsecured Priority Claim

Check the appropriate place if you have an unsecured priority claim, and state the amount entitled to priority. (See DEFINITIONS, above). A claim may be partly priority and partly nonpriority if, for example, the claim is for more than the amount given priority by the law. Check the appropriate place to specify the type of priority claim.

7. Credits:

By signing this proof of claim, you are stating under oath that in calculating the amount of your claim you have given the debtor credit for all payments received from the debtor.

8. Supporting Documents:

You must attach to this proof of claim form copies of documents that show the debtor owes the debt claimed or, if the documents are too lengthy, a summary of those documents. If documents are not available, you must attach an explanation of why they are not available.

A meeting of creditors of the above-captioned debtors and debtors in possession (collectively, the "Debtors"), pursuant to Section 341, 11 U.S.C. §§ 101-1330 (the "Bankruptcy Code"), has been scheduled for July 22, 2002 at 1:00 p.m. (Prevailing Eastern Time) at 80 Broad Street, Second Floor, New York, New York 10004. Creditors are welcome to attend, but are not required to do so. The meeting may be continued and concluded at a later date without further notice.

LAST DATES FOR FILING OF PROOFS OF CLAIM

On June 26, 2002 (the "Order Date"), the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court") entered an order in the above-captioned chapter 11 cases (the "Bar Date Order") establishing August 9, 2002 as the general last day to file claims (the "General Bar Date") in the above-captioned chapter 11 cases. Except as described below, the Bar Date Order requires all Entities, as defined in Section 101(15) of the Bankruptcy Code, including individuals, partnerships, corporations, estates and trusts and governmental units, that have or assert any prepetition claims (as defined in 11 U.S.C. § 101(5)) against any of the Debtors, to file any proof of claim with the Bankruptcy Court so that such proof of claim is received on or before 4:00 p.m. (Prevailing Eastern Time) on the General Bar Date.

For your convenience, enclosed with this Notice are: (1) a proof of claim form (the "Proof of Claim Form") and (2) a statement of the amount and nature of your claim(s) as set forth in the Debtors' schedule of assets and liabilities filed with the Bankruptcy Court on or about June 14, 2002 (the "Schedules").

A list of the Debtors is attached hereto. All capitalized terms not defined herein shall have the meanings ascribed to such terms in the Bar Date Order.

PERSONS OR ENTITIES WHO MUST FILE A PROOF OF CLAIM

The General Bar Date applies to any prepetition claim asserted by any Entity, except that the following Entities do not need to file proofs of claim: (1) any Entity that has already properly filed with the Bankruptcy Court a proof of claim against one or more of the Debtors; (2) any Entity (a) whose claim is not listed as "disputed," "contingent" or "unliquidated" in the Schedules and (b) who agrees with the nature, classification and amount of such claim set forth in the Schedules; (3) any Entity whose claim previously has been allowed by, or paid pursuant to, an order of this Court, including the prepetition claims of the Debtors' postpetition employees and certain of their critical trade creditors; (4) any Debtor or any non-Debtor affiliate of any Debtor, for claims held against any Debtor; (5) holders of equity interests in any of the Debtors, including holders of (a) any share in a corporation, whether common or preferred, and whether or not transferable or denominated "stock" or similar security, (b) an interest of a limited partner in a limited partnership, and (c) a warrant or right (other than a right to convert) to purchase, sell, or subscribe to a share, security or interest of a kind specified in clauses 5(a) and 5(b) of this paragraph that are record holders of such interests (collectively, the "Equity Holders") with respect to such equity interests; provided, however, that each such Equity Holder is required to file a Proof of Claim Form on or before the General Bar Date with respect to (x) any securities fraud claim of any such Equity Holders against the Debtors or (y) any claim of any such Equity Holder that such Equity Holder may have a right to require one or more Debtors to purchase or otherwise acquire or guarantee the equity interests of such Equity Holder, to the extent such claim may exist; and (6) holders of any 9.25% Debentures Due 2022 issued by Ogden Corporation (now known as Covanta Energy Corporation, Cusip No. 676346AF6) (the "9.25% Debentures") or other debt of the Debtors arising solely on account of such holder's ownership interest in or possession of the 9.25% Debentures. The indenture trustee for the 9.25% Debentures shall be responsible for the filing of a single master proof of claim in respect of the 9.25% Debentures, which filing shall be subject to the General Bar Date. Any holder of 9.25% Debentures who wishes to assert a claim against the Debtors that is not based solely on the outstanding prepetition principal and interest due on account of its ownership of 9.25% Debentures must file a proof of claim form on or prior to the General Bar Date.

Notwithstanding the foregoing, any claim of a governmental unit, as defined in Section 101(27) of the Bankruptcy Code, shall be timely filed if it is filed on or before 4:00 p.m. (Prevailing Eastern Time) on September 30, 2002. Consistent with the definition set forth in Section 101(27) of the Bankruptcy Code and the provisions of Section 502(b)(9) of the Bankruptcy Code, the provisions of this paragraph do not apply to any entities that are not governmental units, even with respect to claims that have been or may be asserted by such entities on behalf of a governmental unit.

Pursuant to the Bar Date Order, for any claim related to a rejection of an executory contract or unexpired lease (collectively, the "Rejection Damage Claims") that is approved by an order of the Court entered after entry of the Bar Date Order but before confirmation of the Debtors' plan(s) of reorganization, the Rejection Bar Date shall be the later of (1) the General Bar Date and (2) thirty (30) days after the Debtors send via first class U.S. mail a notice or a copy of the order authorizing the Debtors' rejection of a particular executory contract or unexpired lease to the affected counterparty or lessor, as the case may be, which service shall be rendered on or after the eleventh day after the entry of such order.

The bar date (the "Amended Schedule Bar Date") for the filing of proofs of claims in respect of any disputed, contingent or unliquidated claims listed on any amended schedule (the "Amended Schedule") shall be thirty (30) days after the Debtors send via first class U.S. mail a notice of the relevant Amended Schedule identifying such claim.

Any Entity whose prepetition claim is not listed or is improperly classified in the Schedules, is listed in an incorrect amount or is listed as "disputed," "contingent" or "unliquidated" and that desires to participate in these chapter 11 cases or share in any distribution in these chapter 11 cases must file a proof of claim with the Bankruptcy Court on or before 4:00 p.m. (Prevailing Eastern Time) on the General Bar Date.

CONSEQUENCES OF FAILURE TO FILE PROOF OF CLAIM

Any Entity who is required to file a proof of claim, but who fails to do so in a timely manner, SHALL BE FOREVER BARRED, ESTOPPED AND ENJOINED from (1) asserting any claim that such Entity has

against or in the Debtors that is (a) in excess of the amount set forth in the Schedules as liquidated, undisputed and not contingent or (b) for a different amount, nature or classification than in the Schedules (collectively, "Unscheduled Claims") and (2) from voting upon, or receiving distributions under, any plan of reorganization in these chapter 11 cases in respect of such Unscheduled Claims. If it is unclear from the Schedules whether your claim is disputed, contingent or unliquidated as to amount or is otherwise properly listed and classified, you must file a proof of claim on or before the General Bar Date. Any Entity that desires to rely on the Schedules has responsibility for determining that its claim is accurately listed therein.

RESERVATION OF RIGHTS

The Debtors reserve the right to (1) dispute, or to assert offsets or defenses against, any filed claim or any claim listed or reflected on the Schedules as to amount, liability, nature, classification or otherwise; or (2) designate subsequently any claim as disputed, contingent or unliquidated. Nothing set forth in this notice shall preclude the Debtors from objecting to any claim, whether scheduled or filed, on any grounds.

TIME, PLACE AND PROCEDURE FOR FILING OF PROOFS OF CLAIM

ALL PROOFS OF CLAIMS MUST BE FILED WITH THE BANKRUPTCY COURT SO AS TO BE RECEIVED ON OR BEFORE 4:00 P.M. (PREVAILING EASTERN TIME) ON THE GENERAL BAR DATE OR APPLICABLE BAR DATE AS DESCRIBED HEREIN.
