Enclosed are an original and four copies of this letter, together with an original and four copies of the revised tariff sheets referenced below, for filing in this docket.

As reflected in our letter filed on June 11, 2002, this docket involves a territory amendment application submitted by Florida Water Services Corporation ("Florida Water"). The original application included several parcels proposed to be added to Florida Water's existing service territory in Lake County. Since the filing of the original application, it has been determined that certain portions of the requested new territory do not have a current need for service. Accordingly, Florida Water submitted on June 11th revised tariff sheets which were intended to include only those portions of the originally requested territory for which there is a current need for service. Subsequent to the June 11, 2002 filing, it was brought to our attention by Staff that some of the areas included in the revised legal descriptions were not noticed as part of the original application for this docket. Accordingly, we have prepared the enclosed revised tariff sheets. The endorsed revised tariff sheets delete those areas included in the original application for which there is not a current need for service. The revised legal descriptions include only areas that were originally noticed as part of this docket. A map depicting the areas set forth on these revised tariff sheets has been provided to Richard Redemann of the Commission Staff.

As referenced in the June 11, 2002 letter, Florida Water has reached a settlement with Crystal River Utilities, Inc. which filed an objection in this docket opposing the original the territory amendment application. Counsel for Crystal River has been provided with a copy of the revised tariff sheets. It is our understanding that Crystal River will be filing in the near future a dismissal of its objection.
