## NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING PRO FORMA INTRACORPORATE RESTRUCTURING

## BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated July 30, 2002, Florida Digital Network, Inc. (FDN), M/C Venture Southern Lending Corp. (M/C Venture Southern) and M/C Venture Partners filed with this Commission an application for approval of pro forma intracorporate restructuring whereby FDN will merge with M/C Venture Southern, both subsidiaries of M/C Venture Partners, with FDN as surviving entity. FDN is the holder of Alternative Local Exchange Telecommunications Certificate No. 5715 and Interexchange Telecommunications Certificate No. 7048. FDN has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the service being provided. FDN has further stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing services in Florida, we have reviewed the petition of FDN, M/C Venture Southern and M/C Venture Partners and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Florida Digital Network, Inc., M/C Venture Southern Lending Corp. and M/C Venture Partners' request for approval of pro forma intracorporate restructuring of Florida Digital Network, Inc. is hereby approved. It is further,
