NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

letter dated August 14, 2002, Counsel By Springwell Communications LLC (Counsel Springwell) and WorldxChange Corp. (WorldxChange) filed with this Commission an application for intracorporate reorganization whereby Counsel of approval Springwell, which currently holds 68% indirect interest in will acquire through debt restructuring, WorldxChange, 100% indirect interest in WorldxChange. WorldxChange is the holder of Interexchange Telecommunications Certificate No. 7570. WorldxChange has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the service being provided. WorldxChange has further stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing services in Florida, we have reviewed the petition of Counsel Springwell and WorldxChange and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that Counsel Springwell Communications LLC and WorldxChange Corp.'s request for approval of intracorporate reorganization of WorldxChange Corp. is hereby approved. It is further,
