Arthur "Buzz" Victor, II

A pioneer in the self-storage field, Victor has developed twenty-five min-storage facilities located in eleven states since building his first project in Omaha, Nebraska in 1973. These properties contain more than two million square feet of rentable space. Mr. Victor was founder of the Self-Service Storage Association, the industry's first trade association and served as President for two terms. He served on the board of the International Storage and Transport Association and acted as that group's Chairman in 1993.

In recent years, Victor has turned his attention to the Office Business Center concept (formerly Executive Suites). Victor operates such a facility in Greenwood Village, Colorado containing approximately 30,000 square feed and having 65 separate offices. His newest venture, the Premier Executive Center, now completing construction in Naples, Florida will have 95 offices and suites.

Victor left a career in teh broadcast industry before entering real estate. Victor has served on the board of the Colorado Public Radio (Chairman 2000-2002) since 1996. Colorado Public Radio owns and operates nine radio stations and has a network of 14 translators broadcasting throughout the state.

Barry J. Bender

A graduate of the University of Denver where he received his degree in accounting in 1973 and subsequently obtained his CPA certificate in 1974. Barry spent seven years in public accounting with a big five accounting firm. Barry then worked in the interstate transportation industry as both a controller and Chief Financial Officer for two different trucking companies.

In 1985 he joined Minibrook Partnership as Chief Financial Officer and became a partner in 1995. Minibrook is primarily involved in the management and development of self-storage and currently holds interests in fifteen properties located throughout the United States including California, Colorado, Florida, New York and Pennsylvania.
