VERIZON FLORIDA INC.'S MOTION TO STRIKE NOTICE OF ADOPTION BY GLOBAL NAPS, INC. OF AT&T COMMUNICATIONS OF THE SOUTHERN STATES, LLC, TCG OF SOUTH FLORIDA, AND AT&T BROADBAND PHONE OF FLORIDA, LLC'S <u>MOTION FOR RECONSIDERATION</u>

Verizon Florida Inc. (Verizon) asks the Commission to strike the Notice of Adoption by Global NAPS, Inc. (GNAPs) of AT&T Communications of the Southern States, LLC, TCG of South Florida, and AT&T Broadband Phone of Florida, LLC's Motion for Reconsideration. GNAPs' Notice is improperly filed because it is weeks late.

The final Order in this Docket was issued on September 10, 2002. Reconsideration petitions were due on September 25, 2002. Responses to those petitions were due 7 days later, with 5 additional days permitted if the reconsideration petition was served by mail.

Because GNAPs intended to adopt as its own AT&T's Motion for Reconsideration, GNAPs' Notice should have been filed when AT&T's Motion was, on September 25, 2002. Even if GNAPs' Notice is considered a response to AT&T's Motion, it should have been filed by October 7, 2002. Instead, GNAPs filed its Notice on October 31, 2002. Even under the most liberal interpretation of the Commission's Rules, GNAPs' filing is over three weeks late. It is thus improper and should be stricken.
