Re: Approval of Amendment to the Resale Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and Appliance and TV Rentals d/b/a Fones 4-U (n/k/a Ring Connection, Inc.) pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant the Telecommunications Act of 1996, BellSouth and Appliance and TV Rentals d/b/a Fones 4-U (n/k/a Ring Connection, Inc.) are submitting to the Florida Public Service Commission their negotiated agreement for the interconnection, unbundling of specific network elements, collocation of BellSouth networks, and resale of their telecommunications services to Appliance and TV Rentals d/b/a Fones 4-U (n/k/a Ring Connection, Inc.). The agreement was negotiated pursuant to sections 251, 252 and 271 of the Act. The initial agreement between the companies was filed in FPSC Docket No. 011417-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting this amendment to the negotiated agreement between BellSouth and Appliance and TV Rentals d/b/a Fones 4-U (n/k/a Ring Connection, Inc.) within 90 days of its submission. The Act provides that the Commission may only reject such an amendment if it finds that the amendment, or any portion of the amendment, discriminates against a telecommunications carrier not a party to the amendment or if the implementation of the amendment or any portion of the amendment is not consistent with the public interest, convenience and necessity. Both parties agree that neither of these reasons exists as to the amendment they have negotiated. Therefore, this amendment should be deemed effective by operation of law on February 13, 2003.

**AMENDMENT
TO THE
RESALE AGREEMENT BETWEEN
BELL SOUTH TELECOMMUNICATIONS, INC.
AND
APPLIANCE & TV RENTALS, INC. D/B/A FONES-4-U
DATED SEPTEMBER 20, 2001**

Pursuant to this Amendment to the Resale Agreement between BellSouth Telecommunications, Inc. and Appliance & TV Rental, Inc. d/b/a Fones-4-U, ("The Amendment"), Appliance & TV Rentals, Inc. d/b/a Fones-4-U ("Appliance & TV Rentals, Inc. d/b/a Fones-4-U") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Resale Agreement between the Parties dated September 20, 2001 ("Resale Agreement").

WHEREAS, Appliance & TV Rental, Inc. d/b/a Fones-4-U has changed the name of said business to Ring Connection, Inc. a Florida Corporation.

WHEREAS, the Parties desire that the Resale Agreement be amended to reflect the new corporate entity name.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and in other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The name of Appliance & TV Rentals, Inc. d/b/a Fones-4-U in the Resale Agreement is hereby deleted throughout the Resale Agreement and replaced with Ring Connection, Inc. ("Ring Connection, Inc.").
2. All of the other provisions of the Resale Agreement, dated September 20, 2001, shall remain in full force and effect.
3. Either or both of the Parties are authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
