Dear Sir:

I am astonished at the 200% increase in my water bill. Like all the residents in this subdivision. was aware that the rates were due to increase; I even believed that such an increase was justified. The information that was sent to us mentioned the rate increase in terms of pennies and it did not seem unreasonable. At no time was the full impact of the increase put in terms that could be understood by an average home owner.

Due to the shift work required by my job, I was unable to attend the meetings on this subject. In the back of my mind I also doubted that my presence would alter what was going to happen anyway.

Having lived in the city of Lake City proper I understand how expensive water can be, not the water itself but the treatment of waste water. The rates for the water in the city are actually less than the rates in this subdivision. Even the rate for water in Pompano Beach (one of the most expensive rates in South Florida) were less than this. We are on a septic tank system here so waste water treatment is not even applicable.

I probably would not object as strenuously if the quality of the water and the water pressure had improved 200%. It has not. It probably will not.

Even though the Commission that approved this increase is an appointed body there are elected officials who are responsible for these appointments. There is one person in this subdivision who remembers this; she is writing this letter. She is a registered voter.
