

Dear Vice-Mayor DeVane:

Thank you for your letter of December 27, 2001, to former Chairman E. Leon Jacobs regarding your thoughts and concerns for rates and service provided to the citizens of Winter Park. Your correspondence has been forwarded to me, and I will attempt to address your concerns. As you requested, I have provided for you (see enclosed) the transcripts and sign-in sheets of the November 28, 2001 service hearing held at the Winter Park City Commission Chambers.

Your concern that the ratepayers of Winter Park are not receiving adequate service from Florida Power Corporation (FPC) is currently being addressed by the Commission in several ways. First, the Commission staff is proposing that quality of service be an issue in the utility's current rate proceeding (Docket No. 000824-EI). The Commission will consider the testimony included in the record from the FPC service hearings. I have been informed by staff that the Office of Public Counsel, during issue identification conferences, has indicated its desire to raise a specific issue concerning the quality of service in the Winter Park area. You may contact the Office of Public Counsel to represent your specific concerns in the docket. Commissioner Braulio Baez, the prehearing officer in the docket, will make an official determination identifying all issues at the prehearing conference now scheduled for March 4, 2002.

Also in the rate proceeding, staff is proposing an additional issue addressing whether utility ratepayers should receive refunds in the event that ratepayers experience frequent outages. Staff is preparing testimony on this issue. The filing deadline for staff testimony is January 28, 2002. You can access this testimony through the Commission website at <u>http://www.psc.state.fl.us/psc/dockets.</u>

Second, the Commission staff will consider comments in a rulemaking docket which addresses service quality and reliability (Docket No. 011351-EI). A portion of the proposed rule pertains to the data reporting requirements, which are the basis of some of the concerns you have expressed in your letter. Your proposal that the Commission take action to require utilities to replace distribution lines with chronic reliability problems may also be considered in the above referenced rule docket. Again, I encourage your participation in that proceeding. Staff informs me that a second draft of the rule will be available on the Commission website soon. A workshop is expected to be scheduled for either mid-February or early March in which public input is encouraged. You may consult the docket file online for periodic updates about any schedule changes and file documentation.

The electric distribution service quality has been of particular concern to the Commission during the last several years. The FPSC's Regulatory Review staff has concluded two separate reports investigating the service quality and reliability of FPC service (see attached "Review of Electric Service Quality and Reliability" reports, dated December 1997 and November 2000). The first report (December 1997) identified declines in service quality for FPC from 1992 to 1996; the second report (November 2000) concluded service quality had measurably improved through year-end 1999. In addition, the Commission is currently concluding an audit report on the effectiveness of Florida investor-owned electric utilities in protecting their transmission and distribution systems from lightning strikes. However, these reports provide data for the FPC system as a whole, not by individual communities, cities, townships, counties, etc.

Finally, the Commission has a complaint process whereby individual ratepayers may, through several methods (phone, e-mail, letter, etc) initiate a complaint to the Commission for which the utility is required to respond within a specified time frame. It is the Commission's intent that disputes between regulated companies and their customers be resolved as quickly, effectively, and inexpensively as possible. Chapter 25-22.032, F.A.C., is designed to accomplish that intent. I encourage you to document the problems you are having through our complaint process. The Commission's complaint phone number is 1(800)342-3552. Complaints can also be sent to the Commission website at http://www.psc.state.fl.us/consumers/complaint.

Thank you once again for your letter expressing the concerns you have for the level of service received by the ratepayers of Winter Park. I can assure you that the Florida Public Service Commission will continue to work diligently to protect the quality of service at reasonable rates for all retail customers of the investor owned electric utilities in Florida. We look forward to your continued participation in the process.


