PEFI has indicated in its petition of 2/18/03 that, based on current actual and projected data, it projects it will underrecover fuel and purchased power costs by greater than 10 percent in 2003, which is the materiality threshold for this Commission to consider revising the fuel factors. The utility requests the revision in the fuel factors become effective with Cycle 1 billings in April, 2003. The utility states in its petition that such treatment is necessary in order to minimize the impact of the mid-course correction on customer bills by spreading the increase over the greatest possible time. Staff believes that the level of underrecovery represented by PEFI requires an expedited review process and should be brought forth to the Commission at the earliest agenda. Staff will provide e-mail communication to the utility requesting supplemental information needed to complete Staff's analysis. Staff requests a filing date of 2/25/03 (Tuesday). *By Norm*
