Supplementing our letter of May 14, 2003, requesting approval of a test year for Mid-County Services, Inc. ("Utility"), we provide the following information:

- (a) The requested test year is representative of a normal full year of operation. During the test year, there were no catastrophic events or occurrences that affected operations or that required major reconstruction or repairs other than those usual and customary for plant and equipment of the same age and usage patterns, no material alterations in plant or system capacity, no extraordinary increases in demand or consumption, or significant changes in weather patterns that would alter or affect current methods of operation.
- (b) During the test year, the Utility has made major changes to plant and equipment, specifically, plant and equipment upgrades and modifications. Within that same period of time, there have been no major changes in operational methods.
