REQUEST FOR CONFIDENTIAL CLASSIFICATION

Progress Energy Florida, Inc., formerly Florida Power Corporation, (Progress Energy or the Company), pursuant to Section 366.093, F.S., and Rule 25-22.006, F.A.C., hereby requests confidential classification of the highlighted information on the audit workpapers contained in the sealed envelope enclosed with this request, which Progress Energy provided to the Commission's auditors in response to a Staff document request. In support of this request for confidential classification, Progress Energy states as follows:

Background

1. During the course of the Staff audit regarding Progress Energy's fuel adjustment clause for the twelve months ended December 31, 2002 (Audit Control No. 03-034-2-2), the Staff auditors requested, and Progress Energy and its affiliated coal supplier, Progress Fuels Corporation (PFC) provided, numerous documents for review. A number of these documents containing sensitive competitive information regarding PFC's coal procurement and transportation operations were identified by Progress Energy as confidential on the document request forms (Form PSC/AFA 6 (2/95)).
