NOTICE OF PROPOSED AGENCY ACTION
ORDER GRANTING CERTIFICATE TO PROVIDE
ALTERNATIVE ACCESS VENDOR SERVICES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service
Commission that the action discussed herein is preliminary in
nature and will become final unless a person whose interests are
substantially affected files a petition for a formal proceeding,
pursuant to Rule 25-22.029, Florida Administrative Code.

NUMINA COMMUNICATIONS CORP. (NUMINA) has applied for a
certificate to provide Alternative Access Vendor (AAV) services
pursuant to Section 364.337, Florida Statutes. Upon review of its
application, it appears that NUMINA has sufficient technical,
financial, and managerial capability to provide such service.
Accordingly, we hereby grant Certificate No. 8342 to NUMINA.

If this Order becomes final and effective, it shall serve as
NUMINA's certificate. NUMINA should, therefore, retain this Order
as proof of certification. We are vested with jurisdiction over
this matter pursuant to Sections 364.335 and 364.337, Florida
Statutes.

AAV providers are subject to Chapter 25-24, Florida Administrative Code, Part XIV, Rules Governing Alternative Access Vendor services. AAV providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAFs) of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to NUMINA for payment by January 30th. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve NUMINA from its obligation to pay RAFs.

Based on the foregoing, it

ORDERED by the Florida Public Service Commission that we hereby grant Certificate No. 8342 to NUMINA COMMUNICATIONS CORP., which shall authorize it to provide Alternative Access Vendor services, subject to the terms and conditions specified in the body of this Order. It is further

ORDERED that this Order shall serve as NUMINA COMMUNICATIONS CORP.'s certificate and should be retained by NUMINA COMMUNICATIONS CORP. as proof of certification. It is further


