City Gas personnel may be contacted to answer questions concerning the rate request at 1-800-347-4427, extension 5222.

The interim rates will raise the bill of a typical residential customer using 18 therms per month by \$1.46, or 5.1 percent, exclusive of taxes Other classes of customers will see increases that vary based on their usage.

However, lower wholesale natural gas prices have enabled City Gas to reduce the Gas Cost component of its bill by 20 cents per therm since June. Even with the interim increase, a typical residential customer using 18 therms per month will see a November bill that is actually \$2.16 less than five months earlier, a net decrease of 6.7 percent.
