October Status Report Regarding Zellwood Station Cooperative

Transfer to Orange County

Dear Ms. Merchant:

Pursuant to our prior commitment, I am providing to you and all other parties in this proceeding our eighth status report of activities concerning the transfer of the water and sewer plants from Zellwood Station Cooperative to Orange County for the month of November. The closing is currently scheduled for on or before January 15, 2004. The following events took place during the month of November:

- (1) Orange County met with the St. Johns River Water Management
  District and resolved the allocation issue with the District, subject to
  the submission of a modification of the application. The
  modification will be submitted on or before December 15, 2003.
- (2) The Reuse Requirement Condition was worked out between the County and the Water Management District. The County will put in place a plan to replace the wastewater treatment plant by 2007.
- (3) The Level II Environmental Audit came back with a clean bill of health for the closing. The potential environmental problem turned out to not be a problem.
