MOTION FOR EXTENSION OF DURATION  
OF ORDERS GRANTING CONFIDENTIAL CLASSIFICATION


COMES NOW, BellSouth Telecommunications, Inc., ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, and files it's Motion for Extension of Duration of Orders Granting Confidential Classification, and states as grounds in support thereof the following:

1. On June 19, 2002 the Commission issued Order No. PSC-02-0845-CFO-TP granting BellSouth's Request for Confidential Treatment of Document No. 13013-01 (Cross-Reference Document No. 11886-01), Document No. 13210-01 (Cross-Reference Document Nos. 12155-01), Document No. 13681-01 (Cross-Reference Document No. 12814-01).
2. The reasons BellSouth asserted in support of confidential treatment in its original Request for Confidential Treatment continue to pertain. Specifically, there is still a need to protect customer specific-proprietary business information and information which is not subject to public disclosure.
3. The information requested remains in the possession of the Commission Staff.

4. For the reasons set forth above, and in BellSouth's original Requests for Confidential Classification, BellSouth hereby requests that the Commission enter an Order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of Staff.


