Good morning, Adam. I need your advice. CCA sent me a copy of a Chapter 7 bankruptcy notice for Gordon and Starling Wilder at 7820 Capwood Ave., Temple Terrace, FL.

Gordon Wilder is the President of Laurstar Telecommunications, Inc. located at the same address and which is the subject of the above docket. The bankruptcy notice does not mention this company -- only his personal name.

As you know, we cannot cancel a company's certificate for nonpayment of RAFS when it is involved in a bankruptcy proceeding. Since the bankruptcy appears to be a personal bankruptcy and the company is a corporation, I didn't know whether or not to change the title to a bankruptcy cancellation. CCA went ahead and marked the company as having filed for bankruptcy in MCD records based on the names (Gordon Wilder) matching. Should the company be marked bankruptcy? Please advise.
