The following questions address the need to improve the water quality to the customers of Seven Springs. Please provide responses in that context. Comments and costs related to future growth should be distinguished from those related to the existing customer base.

- 1. Describe the advantages and disadvantages of using packed tower aeration, alternative oxidants, and membrane technologies, as described in Dr. Levine's report, to address customer concerns about water discoloration and odor.
- 2. Provide a description of the steps and timeframes involved in implementing both pilot project tests and the final construction of each of the treatment alternative options described in Dr. Levine's report.
- Provide the capital investment and annual operating expenses associated with the both the pilot projects and the completed construction for each treatment option.
- 4. Provide the estimated rate impact (without rate restructuring) of each of the treatment options.
- 5. Which of the methods recommended by Dr. Levine does Aloha believe would be the preferred method to improve the quality of water? Explain Aloha's reasons for choosing that option, addressing the associated costs, results expected, and why Aloha believes this option will most effectively and efficiently correct the black water problem.
