Pursuant to Commission Rule 25-30.550, Florida Administrative Code, enclosed is a copy of an Water Utility Agreement entered into between Lake Utility Services, Inc., and Highland Real Estate & Investments, Inc., to provide water service to Highland Groves, Phase 2. Lake Utility Services, Inc.'s water treatment plants have a permitted capacity of 8.633 mgd. The current treatment plants connected load is approximately 7.389 mgd, and this Water Utility Agreement is for approximately 12,000 gallons a day. There is sufficient capacity in Lake Utility Services, Inc.'s existing plant to provide water service pursuant to this Water Utility Agreement. This Water Utility Agreement will have no noticeable impact on the Utility's rates due to the amount of demand being placed on the Lake Utility Services, Inc.'s water system, and resultant revenues.


