

- On May 12, 2004, BellSouth filed its Petition for the Establishment of a New Performance Assessment Plan in the captioned docket.
- 2. In light of Commission's Notice in Docket No. 000121A-TP, advising that the Commission will commence a new six-month review workshop in August 2004 to discuss proposed changes to BellSouth's Performance Assessment Plan, BellSouth is hereby withdrawing, without prejudice, BellSouth's Petition in this docket.
