

Dear Ms. Daniel:

This letter responds to your informal information request relating to this docket.

- 1. Regarding the September 11, 2002 letter to which you have referred (the "Letter"), the books and records of HV Utility Systems, L.L.C. ("Utility") do not show that the prior owner of Hacienda Village Mobile Home Park ("Hacienda Village") paid to Hacienda Utilities, Ltd. the funds referred to in the Letter.
- 2. The current owner of Hacienda Village ("Park Owner"), an affiliate and customer of Utility, collected from certain Hacienda Village residents, checks for certain costs referred to in the Letter, as shown in detail on Attachment "A" hereto. This procedure was initiated by the prior owner of Hacienda Village (Diversified Investment Services, hereinafter referred to as "Diversified") pursuant to Chapter 723, Fla. Stat. Please note that Attachment "A" hereto identifies the person who wrote the check, except that for sites 14, 57, 149, 165, 225, 336, and 487 ("Diversified Payors"), the checks were initially written from the Diversified Payors to Diversified, and upon the December 17, 2002 closing on the Hacienda Village property between Park Owner and Diversified, Diversified wrote checks to Park Owner to transmit the funds previously collected from the Diversified Payors.

The Park Owner never cashed any of the checks collected and has returned the checks to the addresses listed on Attachment "A," except that Park Owner is in the process of determining the manner in which to return checks to the seven Diversified Payors.

The audit contains a letter from Hacienda Village MHC, Ltd dated 9/11/02 which refers to "charges to Hacienda Village MHP from Hacienda Utilities, LC for costs associated with bring the wastewater treatment plant into compliance with current regulations." As you are aware, the utility may only collect rates and charges which have been approved by the Commission. Please provide a response to the following questions:

- 1. Did Hacienda Utilities or any affiliate of the utility collect or attempt to collect from Hacienda Village MHP or any other entity the costs referred to in the letter related to DEP required upgrades?
- 2. If so, provide a detailed list of all persons or entities that paid, the dates and amounts paid, and to whom the money was paid.
- 3. If funds were paid, was the money given to the utility? If not, where is that money held today?
- 4. Are the charges still being assessed or collect to date?
- 5. The utility's reasons for attempting to collect the assessment without prior Commission approval.

In addition, in Commission Order No. PSC-93-0375-FOF-SU, in Docket No. 920701-SU, dated March 11, 1993 and Order No. PSC-99-0636-FOF-SU, in Docket No. 981265-SU, dated April 5, 1999 the Commission noted that utility was not using the NARUC system of accounts. In Order No. PSC-93-0375-FOF-SU the utility was required to use the NARUC system of accounts. As a result of the recent staff audit, staff discovered that the utility maintained its books and records out of state, the seller was not using NARUC, and the rate base balances from Order No. PSC-99-0636-FOF-SU were not recorded. Please provide a statement that the purchaser has a copy of the NARUC system of accounts and is committed to following the Commissions rules and orders related to maintaining its books and records.

The staff recommendation in this docket is scheduled to be filed on March 4. Therefore, in order for staff to included the utility's responses to the above questions, your response is needed by February 24. Please let me know if you cannot obtain the requested information by that date.
