### **REQUEST FOR CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida, Inc. (Progress Energy or the Company), pursuant to pursuant to Section 366.093, F.S., and Rule 25-22.006, F.A.C., hereby requests confidential classification of the highlighted information in Progress Energy's response to Interrogatory No. 12 and in the Attachments A and C to the Company's responses to Interrogatory Nos. 9 and 11, respectively, from Staff's Third Set of Interrogatories (the Interrogatory Responses), a copy of which was contained in the sealed envelope enclosed with the Company's Notice of Intent to Request Confidential Classification filed on October 25, 2004. A public version of the Interrogatory Responses, with the confidential information redacted, was attached to each filed copy of the Notice of Intent. In addition, Progress Energy withdraws its claim of confidentiality with respect to the highlighted information in Attachments B, D and E to the responses to Interrogatory Nos. 10, 13 and 14, respectively, included with its Notice of Intent, and has attached unredacted copies to these attachments to this Request. In support hereof, Progress Energy states as follows.

### Justification for Confidential Classification

1. Subsection 366.093(1), F.S., provides that any records "found by the commission to be proprietary confidential business information shall be kept confidential and shall be exempt from s. 119.07(1) [requiring disclosure under the Public Records Act]." Proprietary confidential business information includes, but is not limited to, "[i]nformation concerning . . . contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms." Paragraph 366.093(3)(d), F.S. The designated portions of the Stipulation and Settlement fall within this statutory category and, thus, constitute propriety confidential business information entitled to protection under Section 366.093 and Rule 25-22.006.

2. The highlighted information in the Interrogatory Responses contains detailed, supplier-by-supplier information regarding the minimum and maximum quantities of natural gas (Attachment A, response to Interrogatory No. 9), residual oil (Attachment C, response to Interrogatory No. 11), and distillate oil (response to Interrogatory No. 12) that Progress Energy has contracted to receive in 2004 and in 2005. Disclosure of this information would allow existing and potential suppliers of these fuels to know the Company's current requirements for each fuel, by supply contact component and in total, and the exact time when each supply contract will expire.

3. This knowledge would give these existing and potential suppliers a significant competitive advantage in upcoming bidding and negotiations for Progress Energy future fuel supply requirements for each fuel type, since they can readily identify when the Company will need to secure additional fuel supplies based on the expiration date of each existing supply contract, and the criticality of that need to the Company's fuel supply reliability based on the magnitude of the quantities provided by the expiring contract and the contracts that will soon thereafter. Forearmed with the knowledge of Progress Energy's specific needs and the ability to assess the Company's risk exposure and supply vulnerabilities. these suppliers will be able to tailor their bids and negotiations from a position of greater bargaining strength, and thereby avoid the need they would otherwise fact to make their best offer. As a consequence, Progress Energy's ability to contract for goods and services on favorable terms would be impaired, which would result in higher fuel costs to the detriment of the Company and, ultimately, its customers.

4. The designated information for which confidential classification is sought by this Request is intended to be and is treated by the Company as private and has not been publicly disclosed.

## **Duration of Confidential Classification**

5. Progress Energy requests an 18-month confidentiality period, consistent with Rule 25-22.006 (9)(a), F.A.C. In addition, Progress Energy asks

that the confidential version of the Interrogatory Responses containing the highlighted information be returned to the Company when the Commission no longer needs the information to conduct its business, in accordance with Rule 25-22.006 (9)(b), F.A.C.

WHEREFORE, Progress Energy requests that the highlighted information in the Interrogatory Responses enclosed with the Company's October 25, 2004 Notice of Intent, as modified by the withdrawn claim of confidentiality described above, be accorded confidential classification for the reasons set forth above.
