NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that Coastal Blue Development, LLC's, petition for waiver of Rule 25-6.049(5)(a), Florida Administrative Code, filed on July 19, 2004, in Docket No. 040762-EU was approved by the Commission at its October 5, 2004, Agenda Conference. Order No. PSC-04-0984-PAA-EU, issued October 11, 2004, memorialized the decision. The rule provides that individual electric metering by the utility company shall be required for each separate occupancy unit of new condominiums for which construction commenced after January 1, 1981. The petition was approved on the basis that the purpose of the underlying statute would be achieved by other means and application of the rule would create substantial hardship. Notice of the petition was published in the FAW on August 6, 2004.
