I would like to highlight some things for you, with hopes and dreams to hear something back from you soon. As you know I have been sending you different correspondences pertaining to tragic events that I have been going through since the year 2000.

First, you probably already know in the year 2001 a listening device was planted without my consent on me. Since then different tragic events like the terrorist attack on New York City happened, terrible car and truck accidents have been following me everywhere, and Pop Stars through the world has been dieing.

I have been trying to communicate with you, through letters, with pressure from radiation, and thousands of people following me in and out of my home and office location, to explain that all these tragic events look directly connected to me and different problems I am having with my company.

Jenkins, 5). **A Lawyers Life** with David Fisher by Johnnie Cochran, 6). **My Life** by Bill Clinton, 7). **The Da Vinci Code** by Dan Brown author of Angels & Demons, and 8). **Shock** by Robin Cook Putnam.

It is not just books, I also hear and see everything from CD's to Movies and even Star's are using faces and old memories in codes and unseen events from my life, that I am not being paid for and can not prove without help from someone that know. If you can connect me to the right people, I would very much appreciate it.

Also, I would like this listening device removed, because it has almost completely destroyed my company, and attracts trouble to everyone I speak to, that is why I am not able to hire an Attorney to help.

To end, since March of 2004 our certificate has been cancelled and we are at a \$5,000.00 coin gross lost per month. Which has put our company in great debt that will force us to close our doors completely before the summer of 2005, due to the lost of revenue and the continuing maintenance and care for this company.
