Dear Ms. Blanco:

This letter is in response to Order No. PSC-04-PAA-TC issued on in Docket No. 04193-TC. Please consider this a letter of protest, and an effort to explain the reasons that Southern Telecom Communications holds a PSC payphone provider certificate.

I personally talked with the local Tampa PSC office over a year ago, and was instructed to send a copy of the assessment fee document to that office. I forwarded the document and was told that action was sufficient to remove STC's burden to file the assessment fee, and to cancel the certificate. I later spoke with a very helpful person in your Tallahassee office, Ms. Paula Isler, and am filing this letter, again, to attempt to rectify my company's filing requirements. I understand that whatever action I took a year ago was insufficient, although I had the impression that I had already cancelled my certification.

Southern Telecom Communications, Inc. was granted Pay Telephone Certificate No. 6025 on March 26, 1999. That was the year that STC won a subcontract to maintain payphones at Tampa International Airport for Verizon Communications, the payphone provider. Southern Telecom is an award winning data network cabling company, with no prior experience in payphone technology or maintenance. When Verizon needed a small business subcontractor to maintain their phones at the airport, per the airport's request, CMP Verizon asked STC to respond. Characteristic of STC, we conducted research, COM participated in training, AND registered with the PSC to support our company's performance as a subcontractor to Verizon. The intent was to learn as much about CTR payphones as possible to maintain the best service record for Verizon. THERE NEVER ECR HAS BEEN AN INTENT TO PURCHASE, OWN, OR PROVIDE PAYPHONE SERVICES DIRECTLY. STC DOES NOT OWN PAYPHONES! GCL OPC To resolve this docket, the company respectfully requests that the Commission accept this proposal to voluntarily cancel its pay telephone certificate, instead of the \$1,000 fine MMS \_\_\_\_\_ imposed.
