



# **Re:** Application for Certificate to provide Competitive Local Exchange Telecommunications Service by Southern Telecommunications Services Inc. d/b/a Amway Communication

Dear Mr. Delmas:

Staff has received Southern Telecommunications Services Inc. d/b/a Amway Communication's application for a certificate to provide competitive local exchange telecommunications services in Florida. After reviewing your application, staff determined that Southern Telecommunications Services Inc.'s registration with the Florida Department of State (DOS) was inactive. Staff also determined that Amway Communication was not registered as a fictitious name with that department. On October 4, 2004, staff contacted you and informed you of your requirement to register the company's names with DOS. On October 21, 2004, during another telephone conversation, you informed staff that the name registration applications were mailed to DOS during the prior week. You also stated that after the names were registered with DOS that you would fax copies of the registrations to staff. To date, our records indicate that we have not received the information from you. According to the Florida Department of State's website, Southern Telecommunications Services, Inc. is still inactive and Amway Communications is not a registered fictitious name.

As I informed you during our telephone conversation, in order to obtain a certificate to provide competitive local exchange telecommunications services from the Commission, Southern Telecommunications, Inc. must be an active corporation with the Florida Department of State and you must register the name Amway Communication as a fictitious name.

In addition, in the attached letter dated October 21, 2004, staff informed you that your check for the application fee, check number 417 for \$250.00, dated September 23, 2004, was dishonored for insufficient funds. You were advised that you had 30 days from the receipt of the letter to submit payment in the form of a cashier's check for the full amount of the dishonored

check, plus a \$15.00 service charge for a total amount of \$265.00. The deadline for you to submit the payment was November 20, 2004. To date, our records indicate that a payment has not been received.

If you would like to continue the application process to obtain a certificate to provide competitive local exchange telecommunications services, please register your company names with the Florida Department of State and submit a payment in the amount of \$265.00 to the Commission by **December 21, 2004**. You may fax a copy of your company's name registrations to me at 850-413-6663. Please submit your payment in the amount of \$265.00 to the following address:

If you do not respond by December 21, 2004, staff will assume that you are no longer interested in obtaining a certificate to provide competitive local exchange telecommunications services and the certificate will be denied and the docket closed.
