Braden River Utilities, Inc. was certificated by the Florida Public Service Commission several years ago as an irrigation only water company. Upon review of the provisions of Section 367.022(11), Florida Statues which has been enacted since Braden River Utilities. Inc. received its' certificate, we have determined that Braden River Utilities, Inc. appears to qualify for an exemption from regulation by the PSC. This exemption deals with utilities who provide imigation only water service where potable water service is available from another source. We believe this provision clearly applies to Braden River Utilities, Inc. as it provides irrigation only water service within certain areas of Manatee and Sarasota Counties areas where each County is providing potable water service.

As a result of this exemption enacted some time ago, we do not believe Braden River Utilities, Inc. is any longer a regulated utility and therefore do not intend to file a year 2004 Annual Report or any future Annual Reports and do not attend to pay further regulatory assessment fees and is ready to surrender our certificate to the Commission.
