COMES NOW, B ellSouth T elecommunications, Inc. ("BellSouth"), p ursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, and files its Request for Specified Confidential Classification.

1. On March 14-15, 2005, BellSouth filed its Responses to Florida Public Service Commission Staff's (hereinafter "Staff") Third Set of Interrogatories and Third Requests for Production of Documents. BellSouth's Responses to Staff's Third Set of Interrogatories, Item Nos. 83, 84, 88, and 89 and Third Request for Production of Documents, Item No. 20 contain information that is proprietary to BellSouth. In addition, on March 15, BellSouth filed a Notice of Intent to Request Specified Confidential Classification.

2. On March 21, 2005, BellSouth filed its Second Supplemental Response to Staff's Third Set of Interrogatories, Item No. 82 which contains information that is

proprietary to BellSouth. Furthermore, BellSouth filed a Notice of Intent on March 21, 2005 with respect to BellSouth's Responses to Staff's Third Set of Interrogatory, Item No. 82.

3. Pursuant to Rule 25-22.06(3)(a), BellSouth hereby files this Request for Specified Confidential Classification because the information contained in BellSouth's Responses and Second Supplemental Response to Staff Third Set of Interrogatories and Third Request for Production of Documents includes confidential business information unlized by BellSouth to conduct business. A more specific description of this information is contained in Attachment A. Public disclosure of this information would cause harm to BellSouth and the CLECs. Therefore, such information should be classified as confidential business information pursuant to Section 364.24 and Section 364.183, *Florida Statutes*. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.
