By letter dated January 21, 2005, Chief Counsel for the Joint Administrative Procedures Committee informed staff of the Florida Public Service Commission that proposed rule 25-4.085, Florida Administrative Code, should be revised to disclose criteria by which Service Guarantee Programs should be approved. The Commission added a sentence to the rule disclosing such criteria. The rule now provides that the Commission will consider benefits to customers and the public interest when evaluating Service Gauarntee Programs. The rule text is provided below and the added language is highlighted.
