**Amendment to the Agreement
Between
Business Telecom, Inc.
and
BellSouth Telecommunications, Inc.
Dated March 25, 2003**

Pursuant to this Amendment, (the "Amendment"), Business Telecom, Inc. ("BTI"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated March 25, 2003, ("Agreement") to be effective on date of last signature.

WHEREAS, The Parties desire to change the Notices address in the General Terms and Conditions;
