NOTICE IS HEREBY GIVEN that the Florida Public Service Commission has received from Central Sumter Utility Company, LLC a petition seeking a temporary waiver of Rule 25-30.033 (1) (k), (r), (t), (w), (v), and (w), F.A.C.. The petition requests that these portions of the rule, which address information required for setting initial rates in original water and wastewater certificate proceedings, be waived temporarily to permit bifurcation of the certification proceeding into an initial certification portion, followed at a later date by the rate setting portion of the proceeding.
