

This Commission has received your company's application for a Pay Telephone Service (PATS) Certificate of Public Convenience and Necessity. In answering questions 13, and 14, you neglected to list your Vice President, Jesus Sole's previous relationship with Advanced Payphones U.S.A., Inc. Please amend your Pay Telephone Service's application and submit it to my attention.

According to our records, Advanced Payphones U.S.A., Inc.'s PATS certificate was cancelled in Docket No. 020797-TC for violation of Rule 25-4.0161, F.A.C., Regulatory Assessment Fees; and 25-24.520, F.A.C., Reporting Requirements.
