> Completion of Transaction - Docket No. 041255-TI Re:

On October 26, 2004, GE Business Productivity Solutions, Inc. ("GEBPS") and Business Productivity Solutions, Inc. ("BPS"), by their attorneys, filed a Notification regarding the transfer of substantially all of the assets of GEBPS, including its customer base, to BPS. BPS registered as an IXC telecommunications service provider in order to acquire the GEBPS customers. BPS's registration for authority to provide telecommunications services was filed on October 26, 2004 and amended on November 18, 2004.

This letter is to advise the Florida Public Service Commission ("Commission") that the transactions that were the subject of the Notification have been consummated. BPS now holds the telecommunications authorization in Florida and is now serving the former customers of GEBPS.

As described in the Notification, the transaction has been transparent to customers as they are currently continuing to receive the same services pursuant to the same rates, terms and conditions. To that end, BPS filed an amended tariff with the Commission on November 18, 2004, with an Effective Date of January 1, 2005.
