The Commission received your letter requesting cancellation of the company's pay telephone certificate. Unfortunately, I cannot make the effective date retroactive to 2004. Before staff can recommend a voluntary cancellation, the 2005 Regulatory Assessment Fee return needs to be completed and paid. The 2005 return is enclosed. In addition, our records show that the company has a small past due balance (\$3) for late payment of the 2004 Regulatory Assessment Fee. A breakdown is enclosed. This means a total of \$53 is due.

As soon as the return and payment are received, staff will go forward with the company's request for a voluntary cancellation. The effective date of the cancellation will be February 3, 2005, the date we received your letter requesting cancellation.
