On May 11, 2004, the Department received information concerning the application to expand sanitary sewer and potable water services in Sumter County, by North Sumter Utility Company, L.L.C. Pursuant to the Memorandum of Understanding between the Public Service Commission (PSC) and the Department of Community Affairs, the Department has agreed to review applications for new or revised service and provide comment on the need for service and comprehensive plan consistency. The Department has completed its review and offers the following comments:
