As indicated in its Reply Comments filed on March 1, 2005,<sup>2</sup> SouthernLINC Wireless amended its Petition and withdrew its request for ETC designation in the service area of Quincy Telephone, including the areas where SouthernLINC Wireless provides service, rather than seeking redefinition of Quincy Telephone's service area. In that filing, SouthernLINC Wireless also requested that the rate centers of Sanderson, Live Oak, Luraville, Wellborn in AllTel Florida's service area, the rate centers of Blountstown and Dowling Park in GTC-FL's service area, and the rate centers of Monticello, Tallahassee, St. Marks, Panacea, Sopchoppy, Crawfordville, Madison, and Cherrylake in Sprint – Florida's service area be excluded from SouthernLINC Wireless's ETC designation service area.

Although SouthernLINC Wireless has service capabilities throughout portions of the service areas of AllTel Florida, GTC-FL and Sprint-Florida, in lieu of requesting redefinition of their service areas to include only those areas in which SouthernLINC Wireless has service coverage capabilities, by this filing, SouthernLINC Wireless hereby amends its Petition and respectfully requests that the service areas of AllTel Florida, GTC-FL and Sprint-Florida be withdrawn without prejudice from SouthernLINC Wireless's ETC designation service area. In addition, SouthernLINC Wireless also respectfully requests that the service area of Northeast Florida Telephone be withdrawn without prejudice from its ETC designation service area. As such, at this time, SouthernLINC Wireless seeks ETC designation only in the service area of GTC-Alabama in Florida.

The attached Second Revised Narrative description for revised Exhibit 1 indicates the changes SouthernLINC Wireless is requesting. A list of rate centers, by rural incumbent local exchange carrier, in which SouthernLINC Wireless is seeking designation as an ETC in the State of Florida is also included.
