Amendment to Add Territory in Charlotte County by MSM Utilities, LLC

Dear Sir:

We received a Legal Notice to add territory in Charlotte County dated October 18, 2005 in the mail from MSM Utilities, LLC (applicant). We attended a meeting with Ben Maltese of MSM Utilities, LLC and various area neighbors on November 7, 2005. Mr. Maltese explained the proposed amendment which encompasses our property on Pine Villa Circle. Mr. Maltese indicated that we would not be forced to hook up to the applicant's proposed water and sewer system and that he would have no objection to putting that in writing. However, in the future if applicant sells the system to the county, property owners may indeed be required to hook up to a wastewater system.

By this letter we give you notice that we object to adding our property to this territory. Our property consists of a single family home on five acres. Pursuant to county regulations we were required to put in an above ground septic system which necessitated additional expense to us. We also have a well and water conditioning system on the property. The intent of our property is single family residence and the current well and septic systems are more than enough to service the property. Pine Villa Circle is also a private road and not a county accepted road.
