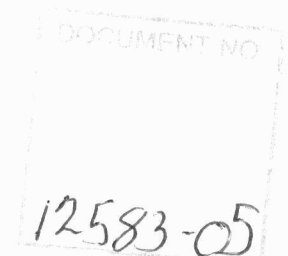

Dear Ms. Salak:

The following are BellSouth's responses to the data requests filed by Staff in the above captioned matter on January 30, 2004:

(1) At this time BellSouth is not planning to revise its 2004 Key Customer Tariff to include the definition of "special promotional rewards." If, however, the Commission desires such a revision, BellSouth will comply.

(2) BellSouth is not planning to revise its 2004 Key Customer tariff regarding the specific level of service that must remain with BellSouth to avoid termination liability. As stated in our response to FDN's Complaint, BellSouth does not require that the billing telephone number remain with BellSouth to avoid termination liability. Both the Key Customer term election agreement and the 2004 Key Customer tariff require only that "some level of local regulated service" remain with BellSouth. Therefore, no revision is necessary. The only time termination liability will apply is if the entire account disconnects.

(3) Under the hypothetical transaction set forth, BellSouth's responses follow:

(A) No, termination liability would not apply between January 1 and January 10th. The term election agreement must be entered and completed in BellSouth's billing system before the charges apply. Once the term election agreement has completed or "accepted" into the billing system, termination liability begins at that point.

- (B) Yes, if the customer disconnected once the term election agreement was completed and accepted through BellSouth's billing system, then termination liability would apply. The term election agreement at that point is in effect.
- (C) Under the same date scenario above, the 36-month commitment begins on January 10th. The commitment will end 36 months later on January 5th.

(4) In response to request 4 (A) and 4(B), please see the following chart:

Number of Days Prior to Expiration	Contact
180 Days	<ul style="list-style-type: none"> • Outbound Calling begins (Calling will continue until the term election agreement has expired) • Bill Message to appear on customer's bill notifying them that the term election agreement will be expiring and that the term election agreement will automatically renew if BellSouth is not notified at least 60 days prior to expiration
150 Days	<ul style="list-style-type: none"> • Direct Mail Letter notifying customer of term election agreement expiration and that the term election agreement will automatically renew if BellSouth is not notified at least 60 days prior to expiration.
120 Days	<ul style="list-style-type: none"> • Bill Message to appear on customer's bill notifying them that their term election agreement will be expiring.
90 Days	<ul style="list-style-type: none"> • 2nd Direct Mail Letter notifying customer on term election agreement expiration and that the term election agreement will automatically renew if BellSouth is not notified at least 60 days prior to expiration.
60 Days	<ul style="list-style-type: none"> • Bill insert notifying customer that the existing term election agreement will be extended for an additional term.

Final Bill	<ul style="list-style-type: none"> • Bill Message notifying customer that the term election agreement has expired and this will be last reward received if they cancelled or notify them that the new term will begin on next bill.

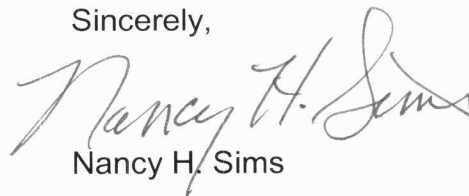
- (C) There is no language in the 2004 Key Customer term election agreement regarding reminders. BellSouth is not planning to revise the term election agreement to include such language because the term election agreement specifically states that the customer is responsible for whether the term election agreement is renewed.
 - (D) The customer must notify BellSouth in writing that he does not intend to renew for another like term. This notification must take place at least 60 days prior to expiration of the term election agreement.
 - (E) No action is required from the customer in order to renew the initial term election agreement.
 - (F) See responses to 4(D) and 4(E). An oral authorization is acceptable for renewal; it is not acceptable for purposes of not renewing the term election agreement.
 - (G) If the term election agreement is renewed, it is treated as a second term with a new term election agreement. There is no “carry over” of termination liability from the initial term election agreement.
 - (H) BellSouth is still in the process of drafting the notifications listed in the chart above in light of the fact that the renewal will not occur in the immediate future. The term election agreement does require a positive response to avert renewal as noted in the responses to 4(C) and (D).
- (5)
- (A) BellSouth wants the tariff citation to be read as broadly as possible and therefore, views it as a “dated by” date.
 - (B) BellSouth is not planning to revise the 2004 Key Customer Tariff because we do not believe it is necessary.
 - (C) The written notifications listed in the chart above will contain an address to which the notification should be sent. There are no special instructions; all that is required is a sentence indicating the customer does not wish to renew the term election agreement.

- (D) BellSouth does not believe the case entitled U.S. v. Waste Management is applicable to this docket for several reasons. First, the small business market in Florida is extremely competitive. Second, BellSouth uses the Key Customer Program to meet this competition. Third, the notification not to renew does not have to be sent by certified mail. Fourth, the customer does not have to give notice to BellSouth that he is going to a competitor and more importantly is not charged termination liability if some level of service remains with BellSouth thereby making it easy for a customer to switch providers. Fifth, the Commission has already found that BellSouth's Key Customer tariffs are not unreasonable or anticompetitive. Sixth, BellSouth's Key Customer termination liability provisions are not excessive or abusive. Finally, the United States Supreme Court case of Trinko may have applicability.
- (E) No. A renewal term equal to the initial term is easy for customers to understand and appreciate.

- (3) BellSouth is still in the process of drafting the notifications and, therefore, has no documents responsive to this request.
