Dear Ms. Smith:

I have asked that the Bureau of Records return 30 pages of copies of audit working papers to you. The documents were originally filed as sensitive highlighted copies with FPL's April 3, 2006, request for confidential classification regarding FPL's 2004/2005 Storm Cost Supplemental Audit -- working papers 44-1/1 through 44-2/2 (30 pages).

FPL has indicated that their only concern with these materials is that the social security numbers within this material remain confidential. This letter describes the steps staff has already taken as well as the steps we propose to take to protect this social security information.

During the field audit, PSC staff obtained 30 pages of materials which contain employee social security numbers. On March 13, 2006, these 30 pages along with other working papers identified as sensitive at the audit exit conference were filed by the staff (Document 02662-06).

On April 3, 2006, FPL requested that certain materials which were gathered during the audit be granted a confidential classification. This request included copies of the 30 pages which contain social security numbers (Document 02989-06).

On May 30, 2006, I updated the audit working papers and sent 30 pages containing the social security information from document 02662-06 to FPL. My May 30, 2006 letter also pointed out other problems within FPL's filing.

Based upon our telephone discussion of June 12, 2006, you indicated that from the working papers under discussion here (30 pages) only the social security numbers were considered confidential.

To close this matter concerning these social security numbers, I have requested that the Bureau of Records return the 30 pages of highlighted social security numbers which were filed by FPL in document number 02989-06. When these materials from the Bureau of Records are returned to FPL, these sensitive social security numbers will no longer be held by the Commission. Further as all social security numbers are returned, I plan to recommend that the remaining information on the 30 working papers which were discussed become public record.

Lastly for clarity, I am providing a table below with a full accounting of 30 working papers affected and staff's plan on how to proceed with this material. Please advise if this accounting meets FPL's intentions.
