All persons who wish to comment are urged to be present at the beginning of the meeting, since the meeting may be adjourned early if no customers are present. One or more of the Commissioners of the Commission may attend and participate in this meeting. The meeting will begin as scheduled and will continue until all of the customers have been heard.

In addition to the customer meeting to be held on Wednesday, October 25, 2006, at 6:00 p.m., one or more members of Commission Staff will be available that afternoon from 2:00 p.m. to 4:00 p.m., to meet with representatives of customer groups, homeowners' associations, and developers who desire a more in-depth discussion of the issues. BACKGROUND

The Utility is a water and wastewater utility whose corporate offices are located at 200 Weathersfield Avenue, Altamonte Springs, Florida. The Utility's water and wastewater facilities are located in Seminole County, Florida. As reported in its Minimum Filing Requirements ("MFRs") filed with the Commission on May 15, 2006, the Utility's revenues per books are \$2,052,465, with operating expenses per books of \$1,856,857, for its water operations, and revenues per books of \$3,287,485, with operating expenses per books of \$2,723,414, for its wastewater operations, resulting in net operating income of \$195,608 for its water operations, and net operating income of \$564,071 for its wastewater operations, per books, before adjustments. The rate increase application has been filed by the Utility because of inadequate earnings.
