Detariffed Common Carrier Basis and Discontinuance of Offering on Tariffed Basis

Dear Ms. Dortch:

The Windstream Incumbent Local Exchange Carriers (collectively "Windstream") identified below hereby notify the Commission that on April 1, 2007, Windstream will begin offering its wholesale and retail Digital Subscriber Line (DSL) on a permissively detariffed common carrier basis and discontinue offering common carrier DSL service on a tariffed basis from its F.C.C. No. 1 Tariff. Windstream provides DSL service as described in the *Broadband Internet Order*.¹ Neither the provisioning of nor the current rates for these services will be affected by this action. The terms and conditions under which DSL will be offered will be available on the Windstream website effective April 1, 2007 (<http://www.windstream.com>) and will also be available for review at Windstream's office located at 4001 Rodney Parham Rd, Little Rock, Arkansas 72212. The geographic areas affected by this change are the areas where DSL is available in the locations served by the companies listed below.




