- 3. The water leak was coming from an old valve. The leak has been stopped. However, the valve is scheduled for replacement shortly since the valve no longer functions properly. I will notify you when that work is completed.

Oakland Shores

After the customer meeting I went to Mr. Danny Ward's house at 622 Lakeland Drive. His house is adjacent to the Oakland Shores water treatment plant. His plastic meter cover does not fit on the concrete meter box. I spoke to him after the meeting and I advised him that the utility probably no longer carried the concrete box and lid. He is not opposed to a new plastic meter box with lid. Please replace with a new plastic meter box with lid, unless you have a concrete lid that fits. He spends a lot of time in his yard. Please be sure to properly landscape

the yard, after replacing the meter box.

The water pipe/valve repair that the utility made near the water plant did not hold and it is still leaking. The construction area was not properly landscaped. Please repair and landscape.

Please let me know when these items are complete.
