On May 18, 2007, the City of Altamonte Springs received notice of the above referenced

"Ouick Take" filed with the Florida Public Service Commission (PSC). This letter is to file an objection to this "Quick Take" for the Oakland Shores area (Water Certificate No. 278-W) based upon Altamonte Springs' ability to provide potable water service to those properties along Maitland Avenue within this area. The properties along Maitland Avenue are currently located in unincorporated Seminole County, but are eligible for immediate potable and reclaimed municipal water services contingent upon their agreement to future annexation. The properties are eligible for rezoning, as MOR-1 (Mixed Office Residential) and, as such, typically require commercial fire protection systems. The City, planning for the conversion of the single family homes along Maitland Avenue to commercial use, or redevelopment by demolition, installed potable water and reclaimed water services to these properties in 1988. Several properties, immediately north of the identified area, have already connected to the City's potable water and

reclaimed water systems. GCL ____ OPC _____ Although we understand that Utilities Inc. of Florida currently has potable water mains in this same vicinity, and in fact has emergency interconnect with the City along Faith Terrace, it is unclear from the proposed "Quick Take" notice whether the purpose of the SCR _____ PSC amendment is for the provision of water service to existing residential homes where SGA _____ service may already be provided by Utilities Inc. of Florida, or if an expansion of the existing customer base is proposed.
