Thank you for your e-mail of June 22nd in which you expressed concerns regarding the sale of Lenvil Dicks' water facilities to the Greater Lake City Regional Utility Authority (Lake City). As you are probably aware, Lenvil Dicks' and Lake City's joint application for the PSC to acknowledge the transfer, was filed on May 17, 2007, in Docket No. 070319-WU. However, as you may not be aware, Columbia County approved the sale of Lenvil Dicks' facilities to Lake City on June 7th. As a consequence, the application in Docket No. 070319-WU was withdrawn from the PSC on June 27th and the docket is being closed.

Since this is probably confusing, here is a brief explanation of what has happened. On May 3, 2007, prior to the establishment of Docket No. 070319-WU, the Board of County Commissioners of Columbia County voted to transfer regulation of the privately-owned water and wastewater utilities within the County from the PSC to the County. This is the County's right under Florida Statutes. Since Columbia County rescinded the PSC's jurisdiction prior to the establishment of Docket No. 070319-WU, the PSC did not have any authority over the matter and Columbia County approved the sale, instead. However, had the PSC's jurisdiction not been rescinded by the County, the PSC is required to approve transfers to governmental authorities as a matter of right under Section 367.071(4), Florida Statutes. The only requirement is for the governmental authority to have obtained the utility's financial statements prior to taking official action.

This is not a complaint against Lenvil Dicks, but rather the sale of Lenvil Dicks water company to the Greater Lake City Regional Utility Authority, and the consequential increase of over 400% in water rates to previous Lenvil Dicks customers. Although it was reported in the local newspaper after the sale that "Each resident has been sent notices by the GLCRUA concerning the purchase and transfer of their water utilities", we certainly received no notice and I have to wonder how many other customers received a notice since "Dicks was the only person in attendance for the public hearing" held on June 18th where the Lake City Council approved the purchase.

This purchase will cause productions customers to from a pricing structure of "\$15.28 a month for water service for the first 15,000 gallons used, and \$1.28 for every 1,000 gallons after that", to "...7,000 gallons per month and water bill for a household would be \$29.71 from the GLCRUA."
