Dear Mr. Fisher:

The Commission received the company's 2006 Regulatory Assessment Fee return form showing net intrastate revenues of \$29,863. Payment of the fee was not included. I am attaching a blank form so that you can file an amended return (please check the "Amended Return" box in the upper left hand corner. You reported gross revenues of \$43,300, less \$13,567 paid to other telecommunications companies, and net intrastate revenues of \$29,863. I'm not sure which figure is incorrect but \$13,567 from \$43,300 is \$29,733. If that is your net intrastate revenues, and if your check is postmarked by March 31, 2007, you should pay \$66.61, which includes the \$59.47 Regulatory Assessment Fee, \$5.95 penalty, and \$1.19 interest. If your check is postmarked between April 1 and April 30, 2007, the amount increases to \$70.17 (\$59.47 fee, \$8.92 penalty, and \$1.78 interest). The penalty and interest charges continue to increase until the fee is paid.

On February 20, 2007, the Commission sent you a delinquent notice via certified mail advising the 2006 Regulatory Assessment Fee had not been paid. The notice stated that companies must pay the fee within 15 days of receipt of the notice to avoid an automatic fine of \$500. According to the US Postal Service, the delinquent notice was delivered on February 22, 2007 (C. Xiong signed for it), which meant payment had to be made by March 9, 2007 to avoid the fine. Once dockets are opened for those companies not complying with the Regulatory Assessment Fee rule/statute, the automatic fines will be imposed and unfortunately, Suite Partners, Inc. d/b/a Summit Executive Suites will be among those companies.
