Dear Ms. Cole:

On July 12, 2007 the Department received a copy of the application from Utilities Inc., of Florida for Amendment of Certificate No. 278-W to extend water service to include the Ravenna Park/Lincoln Heights, Park Ridge and Jansen systems and Certificate No. 225-S to extend wastewater service to include Ravenna Park/Lincoln Heights. All of these proposed service areas are located in Seminole County. Pursuant to the Memorandum of Understanding between the Public Service Commission (PSC) and the Department of Community Affairs, the Department will provide information to the PSC regarding the relationship of the application and the Seminole County Comprehensive Plan, including information concerning the land use categories and the density and intensity of use assigned to proposed service areas.

Utilities Inc., of Florida has applied to the Public Service Commission to extend its water and wastewater service in three residential neighborhoods located in Seminole County. These extension areas, the Jansen, Ravenna Park/Lincoln Heights and Park Ridge neighborhoods are located within the urban service area of Seminole County. All of these neighborhoods are designated Low Density Residential (4-7 dwelling units per acre) on the Seminole County Future Land Use Map. Each of the extension areas is adjacent to Utilities Inc., of Florida's existing certified service areas. The application is for an increase of service for a combined total of 99 water customers in the three neighborhoods and for 36 wastewater customers in the Ravenna COMMEN Park/Lincoln Heights neighborhood.

The Department reviewed the application in coordination with Seminole County staff. The Department has determined that the proposed expansion in the Jansen service area would impinge upon Seminole County's existing service area as adopted in the Seminole County Comprehensive Plan. Therefore, the Jansen application is inconsistent with the Seminole County Comprehensive Plan. The applications for extension in the Ravenna Park/Lincoln Heights and Park Ridge are consistent with the Seminole County Comprehensive Plan.
