On June 26, 2007, BellSouth Telecommunications, Inc. d/b/a AT&T Florida (AT&T Florida) filed its Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code (F.A.C.), for certain information contained in **FPSC Document No. 05095-07**: AT&T Florida's response to Staff's First Set of Interrogatories (No. 18) and Attachments responding to Staff's First Request for Production of Documents (Nos. 3, 4 5, 6, 7, 13, 14, 16, and 17).

On July 17, 2007, AT&T Florida filed its Request For Specified Confidential Classification pursuant to Rule 25-22.006, F.A.C. and Section 364.183, Florida Statutes, for certain information contained in FPSC Document No. 05095-07. Attached to its request, AT&T Florida submitted another copy of the documents previously identified as FPSC Document No. 05095-07: the second copy was identified as **FPSC Document No. 06004-07**.
