PURPOSE AND PROCEDURE

The purpose of this hearing is to consider the petition of Progress Energy Florida and Tampa Electric Company for determination of need for Lake Agnes-Gifford 230 kV transmission line in Polk and Orange Counties and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on August 27, 2007. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
